Excise (Special Provisions) Act No. 13 of 1989

Order under Section 3

BY virtue of powers vested in me by Section 3 of the Excise (Special Provisions) Act No. 13 of 1989, I, Mangala Samaraweera, Minister of Finance and Mass Media, do by this Order,

- (a). amend Item No. 1(b) and 1(c) of the Schedule II of the Order made under that Section and published by the *Extraordinary Gazette* Notification No. 2044/32 dated November 09, 2017 as amended in the *Extraordinary Gazette* Notification No. 2058/34 dated February 15, 2018, by substitution of the following Schedule A hereto; and
- (b). amend the Schedule II of the Order made under that Section and published by the *Extraordinary Gazette* Notification No. 2044/32 dated November 09, 2017 as amended in the *Extraordinary Gazette* Notification No. 2058/34 dated February 15, 2018 as set out in the Schedule B hereto;
