- B** Dates: 30th January & 01st February 2018 Time: Between 10.00 a.m. to 3.30 p.m. Tenderer who wish to bid to the items are required to make a refundable deposit on the following manner

- F** (i) The price quoted must be written clearly and legibly in words and figures.

(ii) Any alterations and amendments should be authenticated by the tenderer as otherwise the offer is liable to be rejected. The successful tenderer has to pay value added tax and PAL as shown in the Tender Sale List additionally with the price on which the Bid Awarded.

- G** The successful tenderer is required to make payment in full and take delivery of goods within 10 working days from the date of awarding tender. Failure to do so will result in the award of each item being invalidated and the refundable deposit being forfeited.
