- B** Dates: 15th & 16th November 2017 Time: Between 10.00 a.m. to 3.30 p.m. Tenderer who wish to bid to the items are required to make a refundable deposit on the following manner

- E** The tenderer should manually sign each and every Bid Form and shall provide all particulars required therein

- F** (i) The price quoted must be written clearly and legibly in words and figures.

(ii) Any alterations and amendments should be authenticated by the tenderer as otherwise the offer is liable to be rejected. The successful tenderer has to pay value added tax and PAL as shown in the Tender Sale List additionally with the price on which the Bid Awarded.

- G** The successful tenderer is required to make payment in full and take delivery of goods within 10 working days from the date of awarding tender. Failure to do so will result in the award of each item being invalidated and the refundable deposit being forfeited.

- H** The Director General of Customs reserves the right to withdraw any item put up for sale at any time. The decision of the Tender Board shall be final on any matter related to the Tender Sale.

- I** Tender documents should be submitted in duplicate and the duplicate to be in the sealed envelope (marked as 2) and may be dropped in the box marked as "Duplicate".

The purchaser shall not be entitled to any remission of the purchase price on any ground whatsoever.
