- A. All Bids should be dropped in the Tender Box placed at the Central Disposal Unit, Third Floor, Customs House; Main Street, Colombo 11, not later than 10.00 a.m. on 17.11.2017 Tender box shall be opened immediately after closing the Tender Box**

- B** Dates: 15th and 16th of November 2017 Time: Between 10.00 a.m. to 3.30 p.m. Tenderer who wish to bid to the items are required to make a refundable deposit on the following manner

- D** Bids for each item should be submitted in original tender forms. These forms could be obtained on payment of a non-refundable deposit of Rs. 300/-.

Bid forms could be obtained between 10.30 a.m. to 3.30 pm 15th and 16th of November 2017.

- E** The tenderer should manually sign each and every Bid Form and shall provide all particulars required therein

- F** (i) The price quoted must be written clearly and legibly in words and figures.  
(ii) Any alterations and amendments should be authenticated by the tenderer as otherwise the offer is liable to be rejected. The successful tenderer has to pay value added tax and PAL as shown in the Tender Sale List additionally with the price on which the Bid Awarded.

- G** The successful tenderer is required to make payment in full and take delivery of goods within 10 working days from the date of awarding tender. Failure to do so will result in the award of each item being invalidated and the refundable deposit being forfeited.

- H** The Director General of Customs reserves the right to withdraw any item put up for sale at any time. The decision of the Tender Board shall be final on any matter related to the Tender Sale.

- I** Tender documents should be submitted in duplicate and the duplicate to be in the sealed envelope (marked as 2) and may be dropped in the box marked as "Duplicate".

- J** **The bidder must satisfy himself to the condition of the goods and the quantities thereof, and the Director General of Customs does not warrant the quality, quantity or condition of the said goods or the title to the goods. The purchaser shall not be entitled to any remission of the purchase price on any ground whatsoever.**
