- A.** All Bids should be dropped in the Tender Box placed at the Central Disposal Unit, Third Floor, Customs House; Main Street, Colombo 11, not later than 10.00 a.m. on 07.03.2019. Tender box shall be opened immediately after closing the Tender Box.

(ii) Any alterations and amendments should be authenticated by the tenderer as otherwise the offer is liable to be rejected. The successful bidder has to pay value added tax and PAL as shown in the Tender Sale List additionally with the price on which the Bid Awarded.

- G** The successful bidder is required to make 50% of the payment within 24hrs of the tender date and should pay balance 50% within 03 working days.
