- E** The bidder should manually sign each and every Bid Form and shall provide all particulars required therein

- F** (i) The price quoted must be written clearly and legibly in words and figures.

(ii) Any alterations and amendments should be authenticated by the tenderer as otherwise the offer is liable to be rejected. The successful bidder has to pay value added tax and PAL as shown in the Tender Sale List additionally with the price on which the Bid Awarded.

- G** **The successful bidder is required to make 50% of the payment within 24hrs of the tender date and should pay balance 50% within 03 working days.**

- H** The Director General of Customs reserves the right to withdraw any item put up for sale at any time. The decision of the Tender Board shall be final on any matter related to the Tender Sale.

- I** **The bidder must satisfy himself to the condition of the goods and the quantities thereof, and the Director General of Customs does not warrant the quality, quantity or condition of the said goods or the title to the goods. The purchaser**
