- A. All Bids should be dropped in the Tender Box placed at the Central Disposal Unit, Third Floor, Customs House; Main Street, Colombo 11, not later than **10.00 a.m. on 17.02.2018** Tender box shall be opened immediately after closing the Tender Box.

- B. Dates: **14th, 15th and 16th February 2018** Time: Between **10.00 a.m. to 3.30 p.m.** Tenderer who wish to bid to the items are required to make a refundable deposit on the following manner (One refundable deposit has to be used for one item only)

- E. The tenderer should manually sign each and every Bid Form and shall provide all particulars required therein
- F. (i) The price quoted must be written clearly and legibly in words and figures.
(ii) Any alterations and amendments should be authenticated by the tenderer as otherwise the offer is liable to be rejected. The successful tenderer has to pay value added tax and PAL as shown in the Tender Sale List additionally with the price on which the Bid Awarded. .
- G. The successful tenderer is required to make payment in full and take delivery of goods within 10 working days from the date of awarding tender. Failure to do so will result in the award of each item being invalidated and the refundable deposit being forfeited.
