- A. All Bids should be dropped in the Tender Box placed at the Central Disposal Unit, Third Floor, Customs House; Main Street, Colombo 11, not later than **10.00 a.m. on 19.09.2019** Tender box shall be opened immediately after closing the Tender Box.
