Dear Sir/ Madam

Imports and Exports Control Regulation No 3 of 2020.

The following Operating Instructions have been issued under the power vested in Imports and Exports Control Act No. 1 of 1969 and in terms of the regulations published in the Gazette Extraordinary No 2182/10 dated June 30, 2020 and Gazette Extraordinary No 2176/19 dated May 22, 2020.

1. Gazette Extraordinary No 2182/10 dated June 30, 2020 (*Annex 1*) has been published to amend the Gazette Extraordinary No 2176/19 dated May 22, 2020.
2. The Negative List published by the Ministry of Finance which is required to implement the Regulation No 10 of the Gazette Extraordinary No 2182/10 dated June 30, 2020 is attached herewith. (*Annex 2*)
3. Items removed from Schedule I
 - i. Sri Lanka Customs shall charge a penalty and release the items removed from schedule I of the Extraordinary Gazette No 2176/19 dated May 22, 2020 except all the items under HS heading 87.04 where the date of loading comes from May 22, 2020 to June 29, 2020, subject to payment which is effected after 90 days from the date of loading.
 - ii. Bank shall effect the payment after 90 days from the date of loading for the instance mentioned above 3(i).
4. Items added to Schedule II from the Schedule I of the Gazette
 - i. Sri Lanka Customs shall charge a penalty and release items which are newly added to the schedule II from the schedule I where the date of loading comes from May 22, 2020 to June 29, 2020 subject to the condition that payment is effected for all items except under HS headings 87.08 and 87.14 after 90 days

from the date of loading and for the items under HS headings 87.08 and 87.14 after 180 days from date of loading.

ii. Bank shall effect the payment for all items under HS headings 87.08 and 87.14 after 180 days and for other items after 90 days from the date of loading accordingly.

5. Items stipulated in the Operating Instruction No. 9 dated June 19, 2020 have been included to the Temporary Suspended List (Schedule I) via the Gazette Extraordinary No 2182/10 dated June 30, 2020. Therefore the Operating Instruction shall be applied for goods which on board date comes during the time period of June 20, 2020 to June 29, 2020.

6. These instructions shall be implemented with immediate effect.

Regulations

1. These regulations may be cited as the Imports and Exports (Control) Regulations No. 3 of 2020.
2. The amendments prescribed in these regulations shall be effective only for importations of goods which are loaded on or after 30 June 2020 at the loading port and Regulation No. 8(d) shall be effective for the goods loaded on the time duration mentioned therein.
3. Regulations No. 4, 5, 6, 8, 9, 10 and 18 of the Gazette (Extraordinary) No 2176/19 dated May 22, 2020, are hereby deleted and following regulations are included instead.
 4. a) An importer, registered under Temporary Import & Export Processing Scheme (TIEP) or recommended by the Director General of Board of Investment of Sri Lanka or Director General of Export Development Board and who imports any goods including items stipulated in Schedule 1 & II for the purpose of processing for direct export or for the supply to another exporter, shall declare a total value of goods exported in a quarter and the foreign remittance received in respect of such exports as certified by the local bank as follows;
