**INTELLECTUAL PROPERTY RIGHTS ENFORCEMENT UNIT (IPREU)**

An Intellectual Property Rights Enforcement Unit (IPREU) is hereby established under the Preventive Directorate of Sri Lanka Customs. This Unit has been established with the aim of enhancing the activity of the Customs in enforcement of the provisions of the intellectual property Act relating to importation and exportation of goods and ensure a safer society by protecting it from counterfeit and pirate goods.

The Intellectual Property Rights Enforcement Unit will maintain a record of the details of Intellectual Property Rights Holders and disseminate such information to the Customs Officers at the border, enabling them to better enforce the provisions of the Intellectual Property Rights Act. Rights Holders are required to register themselves at IPREU. The necessary forms are available on the Customs website.

The Intellectual Property Rights Enforcement Unit will, under the guidance of Director (Preventive) formulate work procedure, as to the steps to be taken, when a case is detected.

All other units of the Customs should co-ordinate with IPREU, whenever they detect IPR violation case.
