Government Notifications

IMPORT AND EXPORT (CONTROL) ACT, No. 1 OF 1969

REGULATIONS made by the President under Section 20 read with Sub-section (3) of Section 4 and under Section 14 of the Import and Export (Control) Act, No. 1 of 1969 and paragraph (2) of Article 44 of the Constitution.

Regulations

1. These regulations may be cited as the Exports (Standardization and Quality Control) Regulations.
2. *Gazette* (Extraordinary) No. 1808/6 dated 29th April, 2013 is hereby cancelled and the said notification is published again in this *Gazette*.
3. No exporter shall export the articles set out in Column I of the Schedule hereto unless they conform to the applicable Sri Lanka Standard set out in the corresponding entry in Column II of that Schedule.
4. Every exporter shall in respect of each article exported by him, furnish a certificate of conformity with the Sri Lanka Standard stipulated for that article issued by either laboratory accredited for the testing of the particular article or a laboratory recognized by the Sri Lanka Standards Institution.
5. Every exporter in respect of each article exported by him shall obtain a certificate of clearance issued by the Director General of Sri Lanka Standards Institution by providing conformity certificate obtained from either laboratory accredited for the testing of the particular article or a laboratory recognized by the Sri Lanka Standards Institution.
6. Every exporter who exports any article set out in the Schedule shall (before Customs Clearance) make available to the Director General of Customs with Certificate of Clearance issued by the Director General of Sri Lanka Standards Institution with all documents relating to the articles and samples from each consignment as may be required by them

7. The processing of article(s) covered under this regulation shall be assessed for conformity assessment procedures and guidelines laid down by the Director General of the Sri Lanka Standards Institution.
8. No exporter shall export the items covered under this regulation unless Certificate of Clearance is granted to him to do so, by the Director General of the Sri Lanka Standards Institution.
9. These regulations are effective from 01st January 2014.
