Imports and Exports Control Regulations 11 of 2021

The following Operating Instructions are issued under the power vested in Imports and Exports (Control) Act No. 1 of 1969 and in terms of the Regulations No. 5 of the (amended) Gazette Extraordinary, No. 2044/40 dated November 09, 2017.

1. The Gazette Extraordinary No. 2238/45 dated July 31, 2021, was published in order to regulate the Importation of Chelated Mineral and Micro Nutrients. Importation of these goods was previously banned and those have been brought under Import Control License (ICL) by said Gazette from July 31, 2021.
2. Commercial banks shall not proceed with any payment in respect of the importation of items mentioned under the regulation No. 3 of the aforesaid Gazette without a valid ICL from July 31, 2021.
3. Sri Lanka Customs shall not release the items mentioned under the regulation No. 3 of the aforesaid Gazette without a valid ICL from July 31, 2021.
4. Sri Lanka Customs and Commercial banks shall refer all instances to this Department on importation of items mentioned in the regulation No. 3 of the aforesaid Gazette which was loaded from May 06, 2021 – July 31, 2021.

Imports and Exports (Control) Act, No. 1 of 1969

IN terms of the powers vested in me by Section 20 read together with Sub-Section 4(1) and Section 14 of the Imports and Exports (Control) Act, No. 1 of 1969 as amended by Act No. 48 of 1985 and Act No. 28 of 1987, I, Basil Rajapaksa, the Minister of Finance, promulgate following Regulations.

REGULATIONS

1. These Regulations may be cited as the “**Imports and Exports (Control) Regulations No. 11 of 2021**”.
2. The Regulations promulgated in this *Gazette* shall only be applicable to importation of goods which have the date of Bill of Lading / Airway Bill on or after **31** July 2021.
3. Goods, described below together with their corresponding entries stipulated in the **Schedule IV** of the Special Import License Regulations, published in the *Gazette Extraordinary* No. 2044/40 dated 09 November 2017, as amended, are hereby deleted from the said **Schedule IV**, referred above and included into the **Schedule I** of the said *Gazette*.
