IMPORTS AND EXPORTS (CONTROL) ACT, No. 1 OF 1969

IN terms of the powers vested in me by Section 20 read together with Sub-Section 4(1), Section 6 and Section 14 of the Imports and Exports (Control) Act, No. 1 of 1969 as amended by Act, No. 48 of 1985 and Act, No. 28 of 1987, I, Mahinda Rajapaksa, the Minister of Finance, promulgate following Regulations.

REGULATIONS

1. These Regulations may be cited as the “**Imports and Exports (Control) Regulations No. 08 of 2021**”.
2. The Regulations prescribed in this *Gazette* shall only be applicable to the importation of goods which have the date of Bill of Lading/ Air Waybill on or after 11 June 2021.
3. Goods described below together with their corresponding entries shall be inserted into the **Schedule I** of the Special Import License Regulations, published in the *Gazette Extraordinary* No. 2044/40 dated 09 November 2017, as amended.
