Imports and Exports (Standardization and Quality Control) Regulations No. 01 of 2022; Imports and Exports (Control) Regulations No. 02 of 2022 and No. 03 of 2022".

The following Operational Instructions are issued under the power vested in Imports and Exports (Control) Act No.1 of 1969 and in terms of Regulations No. 5 added to the regulations of Gazette Extraordinary No. 2044/40 dated November 09, 2017 by the Imports and Exports (Control) regulations No 4 of 2021 published in the Gazette Extraordinary No. 2222/31 dated April 06, 2021 and in terms of Regulations No. 17 of Gazette Extraordinary No. 2231/18 dated June 11, 2021

- 1. The Gazette Extraordinary No. 2262/16 dated January 11, 2022, has been published to continue Standard requirement for Brown Sugar and White Sugar as per new HS codes and to bring Liquefied Petroleum Gas (LPG gas) and accessories under the Standard Inspection Scheme. (Commercial Banks has no responsibility in implementation of regulations included in this gazette)
- 2. The Gazette Extraordinary No. 2262/17 dated January 11, 2022, has been published to continue the Import Control License requirement for Brown Sugar as per the new HS codes and to bring shells of a marine specie under Import Control License.

3. The Gazette Extraordinary No. 2262/18 dated January 11, 2022, has been published to remove Temporary Suspension on long grain rice and to continue Temporary Suspension on fish fillet as per new Hs codes.

In case of absence of a laboratory facility to issue conformity certificate of Standard for any goods under Serial No. 128 of Schedule I of this Gazette, such cases shall be processed only in terms of Regulation No. 4 of the Gazette (Extraordinary) No. 2064/34 dated 29 March 2018 until such laboratory facility, accredited by Sri Lanka Accreditation Board, is established.
- 6. If any importers import any goods, mentioned under Serial No. 128, in violation of Regulation 5 above, Shall not be permitted for customs clearance and shall be reexported within Thirty (30) days from the date of refused of permission.
