**PORTS AND AIRPORTS DEVELOPMENT LEVY ACT, No. 18 OF 2011**

**Order under Section 3**

BY virtue of the powers vested in me by Sub-section (3) of Section 3 of the Ports and Airports Development Levy Act, No. 18 of 2011, I, Basil Rajapaksa, Minister of Finance do hereby this Order, amend the Order published in the Extraordinary Gazette Notification No. 2152/32 dated December 05, 2019 by,

- I. Inserting to Schedule I of said Order, of the articles specified in Column III corresponding to the HS Headings and HS Codes specified in Columns I and II and Concessionary Rate specified in Column IV of the Schedule I hereto; and
- II. Inserting to Schedule III of said Order, of the articles specified in Column III corresponding to the HS Headings and HS Codes specified in Columns I and II and Exemptions specified in Column IV of the Schedule II hereto.
