Imports and Exports Control Regulations No. 06 of 2022

The following Operating Instructions are issued under the power vested in Imports and Exports (Control) Act No. 1 of 1969 and in terms of the Regulations No. 5 of the Gazette Extraordinary, No. 2044/40 dated November 09, 2017.

- 1. The Gazette Extraordinary No. 2274/42 dated April 09, 2022, has been published to bring selected items under Import Control License (ICL).
- 2. Sri Lanka Customs shall not release the items which shipped on or after April 10, 2022, specified under regulation No. 3 of the Gazette Extraordinary No. 2274/42 dated April 09, 2022, without a valid ICL.
- 3. Commercial banks shall not proceed with any payment in respect of the importation of items, shipped on or after April 10, 2022, mentioned under the regulation No. 3 of the Gazette Extraordinary No. 2274/42 dated April 09, 2022, without a valid ICL.

Imports and Exports (Control) Act, No. 1 of 1969

IN terms of the powers vested in me by Section 20 read together with Sub-Section 4(1), Section 6 and Section 14 of the Imports and Exports (Control) Act, No. 1 of 1969 as amended by Act No. 48 of 1985 and Act No. 28 of 1987, I, M.U.M. Ali Sabry, the Minister of Finance, promulgate following Regulations.

REGULATIONS

- These Regulations may be cited as the "Imports and Exports (Control) Regulations No. 06 of 2022".
- 2. The Regulations prescribed in this Gazette shall only be applicable to the importation of goods, which have the Shipped-on Board date of Bill of Lading / Airway Bill on or after 3.9... April, 2022.
- Goods described below together with their corresponding entries shall be inserted into the Schedule I of the Special Import License Regulations, published in the Gazette Extraordinary No. 2044/40 dated 09 November 2017, as amended.
- License shall be issued for importation of goods, specified under the Serial Numbers from 270 to 370 in the Schedule I of this Gazette subject to the recommendation of the Secretary to the Ministry of Finance.
- 5. Any importers, who intend to import any goods, specified in the Schedule I of this Gazette, shall have a valid License, issued by the Controller General of Imports and Exports Control, prior to the Shipped-on date of Bill of Lading / Air Waybill of such importation.

These instructions shall be implemented with immediate effect.
