Dear Sir/ Madam

Imports and Exports (Control) Regulations No.13 of 2022

This has reference to the Operating Instructions No. 10/2022 dated August 24, 2022, on the above subject.

1. The instruction No. 2 (ii) of the aforesaid Operating Instructions shall be amended and read as follows;

“2 (ii). For enterprises registered under Section 17 of BOI Act and imports goods for processing and re-export purposes – The list of enterprises, prepared by BOI.”

2. The list mentioned above will be shared with Sri Lanka Customs and Licensed banks by the Controller General of Imports and Exports.

3. The BOI shall update the list of enterprises time to time as appropriately for the effective implementation of instruction referred in 2 (ii).

Therefore, Director General of Customs may clear such consignments accordingly.
