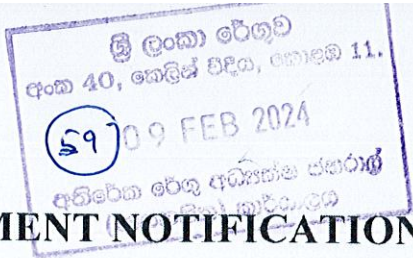
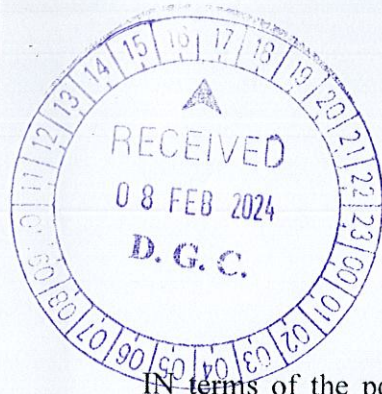

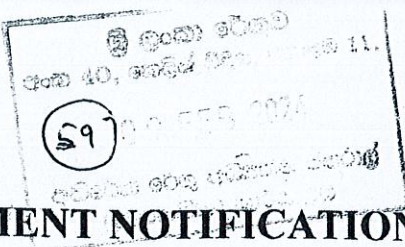
REGULATIONS

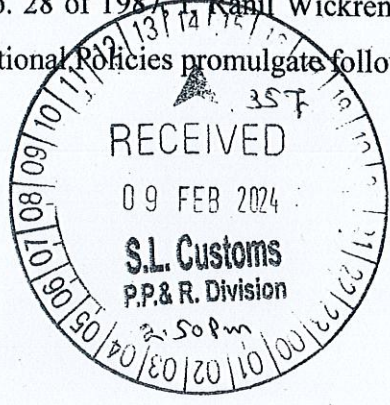
