Responsive bidders should pay 50% of the bidding amount without taxes who is eligible to get the letter for obtaining relevant license/approval. The license should be submitted within one month.
- **H.** The Director General of Customs reserves the absolute right to cancel a sale at any time before removal of goods from the customs premises. The decision of the Tender Board shall be final on any matter related to the Tender Sale.
- The bidder must satisfy himself to the condition of the goods and the quantities thereof, and the Director General of
 Customs does not warrant the quality, quantity or condition of the said goods or the title to the goods. The
 purchaser shall not be entitled to any remission of the purchase price on any ground whatsoever.
